## 4.3 PIC I Business Meeting

ASEE membership is down ~8%. This is predominately due to non-renewal of memberships and financial constraints.

PIC I Best Paper Award recipient is Stephen J. Ressler for his paper submitted this year titled "Assessing the Standards for Assessment: Is it Time to Update Criterion 3?"

A total of 1,421 papers were accepted to the ASEE conference this year. Overall acceptance rate was  $^{\sim}88\%$ .

ASEE Executive Director will retire as of 01 November 2010. An interim-Director will be appointed. A national search will be conducted.

Smoothpaper will not be used again. It will be replaced with a system named Monolith. The new system will be fully integrated with other ASEE business information. The system allows for each Division to define their own abstract/paper submission deadlines.

A proposed change to the PIC bylaws to change the committee member term length from 2 years to 3 years will be voted on this week. The change will facilitate a greater level of continuity within the committee.

## Activities over past year

- ASCE Student Chapters and International Student Groups
  - As we look to the future of our civil engineering profession, ASCE continues to play a key role in student development and education.
    - Nearly 27,000 undergraduate students are currently student members of ASCE.
    - O To prepare these rising leaders for our profession, the Committee on Student Activities (CSA) of EdAC hosted three Workshops for Student Chapter Leaders (WSCL) in conjunction with the 2010 Leadership Conferences. Overall attendance at the WSCL totaled 455 students representing 109 ASCE Student Organizations, including three AEI Student Chapters. Students departed the WSCLs informed, motivated, and energized for the challenges of leading their Chapters.
    - In addition to other activities, student leaders planned, coordinated, and conducted annual student conferences in 18 geographic regions during spring 2010. These Student Conferences typically host over 5,000 ASCE student members per year.
    - 2010 Robert Ridgway Award for most outstanding ASCE Student Chapter was presented to the California Polytechnic State University, San Luis Obispo ASCE Student Chapter in May 2010.
    - 2010 Richard J. Scranton Outstanding Community Service Award was presented to The Citadel in May 2010.
- ASCE's ExCEEd Teaching Workshops 2009 & 2010:
  - ExCEEd Teaching Workshops (6 day) 2009 Open to all civil engineering faculty; 24 participants graduated from the Northern Arizona University site with another 24 participants graduating from the US Military Academy site. This brings us to an eleven year total of 23 workshops; 527 CE graduates; 206 different colleges & universities.

- ExCEEd II New 1.5 day advanced-level workshop for graduates of the ExCEEd Teaching Workshop held July 17-18, 2009 at Northern Arizona University with 16 participants.
- Continue to grow a sizeable body of seasoned presenters, mentors, and assistant mentors.

## CE Division's Historical Files

The files in my possession include many administrative documents (agendas, minutes, and treasurer reports), past newsletters, and approximately 120 copies of the booklet *ASEE Civil Engineering Division – Divisions Chairs 1935-1993*. #### 8.1 The Awards Committee

The Awards Committee shall:

- 8.1.1 Be appointed by and be responsible to the Executive Board. The members of the committee shall be made up of the three most recent living Division Past Chairs. The Chair shall be the Senior Past Division Chair.
- 8.1.2 Be concerned with advancing civil engineering education by emphasizing noteworthy accomplishments. Such accomplishments may include, but are not limited to, technical papers in ASEE Annual Conference Proceedings and meritorious service to civil engineering education in general and the Civil Engineering Division in particular. The committee shall give attention to identifying and nominating Division members worthy of Fellow status in the ASEE. Nominations for awards may be submitted to the Division Chair by the incumbent Standing Committees and by interested members of the Division.
- 8.1.3 Annually select recipients of the Glen L. Martin Best Paper Award, the George K. Wadlin Distinguished Service Award, and the Gerald R. Seeley Award. Recipients are selected by a vote of the Awards Committee.
- 8.1.3.1 The Glen L. Martin Best Paper Award is given for the best paper on a topic in civil engineering education. Eligible papers include those presented at the ASEE Annual Conference and published in the ASEE Annual Conference Proceedings of the previous year's Conference. Recipients are awarded engraved plaques.
- 8.1.3.2 The George K. Wadlin Distinguished Service Award is given for outstanding service in support of civil engineering education. This award is the most prestigious award presented by the Civil Engineering Division. The winner shall be announced to the general membership of the Civil Engineering Division no later than one month prior to the ASEE Annual Conference. The recipient is awarded an engraved plaque.
- 8.1.3.3. The Gerald R. Seeley Award is awarded to a civil engineering faculty member with five or fewer years of experience as a full-time faculty member at any rank. The basis for selection is the quality of a paper submitted for presentation at the upcoming ASEE Annual Conference. The Awards chair shall annually announce the Awards to the Division membership at the time for the call for abstracts. The Award consists of a \$500 reimbursement for conference registration, related travel, and attendance at CE Division social events and business meetings, as well as an engraved plaque. Applications for the Gerald R. Seeley Award must be submitted within one week of submission of final paper for the upcoming Annual Conference. The applications must include a statement of intent to apply for the award, a current CV or biographical sketch (2-page maximum), a statement of eligibility (related to teaching experience), and a statement describing the relative contributions of co-author(s) on the paper. Applications should be submitted to the Program Chair of the Division.
- 8.1.4 Assist the Program Chair in selecting the CE Division's nominee(s) for the ASEE Best Paper Award.

#### Bylaws of the Civil Engineering Division, Draft as of March 21, 2006

- 4.7.2.1 The Director serving the third year of a term shall be the Senior Director and shall be the parliamentarian at all meetings conducted by the Division. The Senior Director shall be responsible for an annual review of the Bylaws to keep them current.
- 4.7.2.2 The Director serving the second year of a term shall be the Mid-term Director and shall chair the Membership Committee.
- 4.7.2.3 The Director serving the first year of a term shall be the Freshman Director.
- 4.7.3 Be eligible to hold more than one position in the Division, although such multiple assignments should be limited to special situations to ensure the maximum number of the Division's membership are involved in the Division's activities.
- 4.7.4 Be eligible to be re-elected to a second consecutive three-year term. No Director shall serve more than six consecutive years. The ranking of the Directors in Section 4.7.2.1 shall govern with the first year of the second three-year term being identified as the Freshman Year.

#### 4.8 The Executive Board

The Executive Board shall:

- 4.8.1 Assist the Chair in administering the affairs of the Division and assist the Program Chair in planning and organizing the program for the ASEE Annual Conference.
- 4.8.2 In the event that a vacancy should occur in the office of the Division Chair, fill the position with a Past Chair of the Division. The Past Chair shall have had working experience and have served as a liaison member on the ASCE EdAC or the ASCE CC&A.

#### 4.9 The Editor

The Editor shall:

- 4.9.1 Be appointed by the Executive Board for a three-year term and shall serve on the Executive Board as a voting member.
- 4.9.2 Be responsible for editing, producing, and circulating the Civil Engineering Division Newsletter.
- 4.9.3 Be responsible for keeping the Division website
  - (http://www.asee.org/members/organizations/divisions/civil.cfm) up to date as directed by the Executive Board.
- 4.9.4 Be responsible for other Division publications as directed by the Executive Board.

#### 4.10 The THE Historian

The THE Historian shall:

- 4.10.1 Be appointed by the Executive Board for a five-year term and shall serve on the Executive Board as a voting member.
- 4.10.2 Be responsible for maintaining the historical documents (minutes, treasurers' reports, etc.) of the Civil Engineering Division.
- 4.10.3 Be responsible for editing, producing, and circulating the publication "Civil Engineering Division Chairs."
- 4.10.4 Be responsible for other Division publications as directed by the Executive Board.
- 4.10.5 Be responsible for maintaining an up-to-date list of the Division's past and present Officers, Directors, Secretary-Treasurers, Editors, and Historians and the year(s) they served.
- 4.10.6 Be responsible for obtaining a 3x5-inch photograph of the Chair and maintaining an album of all the past Chairs for archival purposes.
- 4.10.7 Be responsible for maintaining an up-to-date list of all the Division's award recipients, including the names of the awards and the year received and communicating this information to ASEE Headquarters.
- 4.10.8 Be responsible for collecting the "drink tickets" of all members and guests who do not wish to consume alcoholic beverages at the "Rap" session and/or the Annual Division Banquet.
- 4.10.9 Be responsible for using his/her discretion and good judgment in deciding how (and if) to redistribute the "drink tickets" collected in accordance with Section 4.10.8.

#### Section 5. Election of Officers

- 5.1 The Nominating Committee shall:
  - 5.1.1 Nominate at least one member of the Division for each office to be filled: Chair, Vice-Chair, Director, and when necessary Editor, Secretary-Treasurer, and Historian. Candidates must be willing and able to serve.
