4. PIC I Report Agnieszka Miguel
  - Sean St.Clair asked her to forward the statistics report to the Division.
  - Conference Code of Conduct – ASEE does not have a method of dealing with violators. Agnieszka Miguel indicated ASEE has created an Ethics Task Force to determine the process for addressing violations to Code of Conduct, plagiarism, missing authors, etc.
  - Financial Issues – Fiscal YR 2017 – ASEE put \$350K in reserve account.
    - Fiscal YR 2018 projected reserve is the same. The goal is about 25 percent in reserve.
  - Conference update: One attendance report indicated 3026 attendees (which down from last year by 200) but another report gave indicated 3700 attendees. Miguel will verify and notify the Division.
  - ASEE is looking at division diversity statements and Miguel indicated our Division's very brief statement may need expanded.
  - ASEE is considering creating one set of bylaws for all the PICs instead of separate ones.

- This year is the 125<sup>th</sup> Anniversary of ASEE and Miguel indicated there was available swag at the ASEE Anniversary booth in the Expo.
- Question and Answers:
  - Tom Lenox asked if the attendance was good, normal, low, etc. He noted the increasing conference cost and the possible effect on reducing attendance.  
Ans: 3026 would be low attendance but 3700 would be a big improvement. Miguel needs to verify actual attendance.  
Miguel said ASEE has a task force to determine why people are leaving and who are the members. She doesn't think the cost of the conference has gone up. She indicated her view that if there were panel sessions or more discussions and not just publish to present that we might get more attendees.
  - Jim O'Brien informed Miguel that ASCE thinks the registration is too high and that ASCE or a portion of the ASCE team will not be back next year. He asked how the reserves compared to annual operating costs.  
Ans: \$2 million in operating costs and 2017 was the first time ASEE was able to put money in reserve.
  - Sean St.Clair indicated he was told in the PIC meeting that Civil Engineering is one of the few Divisions without a Diversity Delegate.  
Ans: Miguel explained role saying they would serve on the Diversity Committee that comes up with diversity initiatives and started the safe zone training. The plan is to keep the committee active after its initial start during the year of Diversity. Responsibilities of the delegate include: Conference calls throughout the year to develop programming for the annual conference. Send name to Stephanie Farrell (the incoming president) who is the chair of the division.
  - Norm Dennis noted the paper submission software worked better than ever and there were no glitches. Andrea Welker confirmed.
  - Jim O'Brien questioned why ASEE is looking to "lower levels" for diversity statements and directing that they need expanded. Shouldn't all of ASEE (members, divisions, etc.) be expected to comply with ASEE's own diversity statement?
- 5. ASEE CE Division and related ASCE reports
  - 5.1. 2018 Conference Overview Andrea Welker
    - 5.1.1.
      - 106 Abstracts received, 17 rejected and 55 papers submitted. 14 papers went to posters. 8 technical sessions with 5 papers (one with 6 papers). 1 workshop with 18 attendees. 5 co-sponsored sessions. There are 44 people registered for the Banquet and there is a bus to transport.
      - The Executive Meeting was held as an electronic meeting a few weeks ago. This allowed more time between the two meetings to get things ready for this meeting and allowed for additional technical session at the conference.
      - The RAP session had approximately 125 attendees.

Tonya Nilsson noted that we have been spending more than we have been earning so we need to raise additional funds each year or significantly reduce costs at the Rap Session and Banquet.
  - 5.3. PIC I business meeting report Sean St.Clair  
*Held Sunday, June 24,*

- ASEE wants divisions with high balances to spend down their Bass Account.
- Interest in Diversity Committee: Two division members expressed interest in serving to Andrea Welker after she sent out an email request. Andrea Welker forwarded their names to Stephanie Farrell. If others are interested, Welker has full details of the position.
- We need to submit officer report and signature page and the incoming treasurer, David Saftner, needs to sign paperwork to become account signee.

5.4. ASCE Committee on Education report

Matt Roberts

- COE is willing to send out survey to Department Heads on whether ASEE membership is valued. Matt Roberts asked who in this division will help him draft survey questions. Matt Lovell noted as incoming Membership Chair he would help.
- ASCE will hold a Civil Engineering Education Summit to look at the future of Civil Engineering Education. This will be May 2019.
- COE is working on strategic plan, which is forthcoming.
- Some COE tasks include: the Body of Knowledge and how to support programs implement the BOK and Innovations in Civil Engineering education.
- Discussions are underway regarding changing the name of the ASCE Journal of Professional Issues in Engineering Education and Practice to make it more specific to Civil Engineering education.
- Leslie Nolen distributed the list of Past Year Activities for ASCE Educational Activities. (See Attachment #4) The Department Heads Council was held in May at Drexel about 105 chairs in attendance.

6.3. Membership Committee Report

Steve Burian

- 6.3.1. Attachment #5 shows the downward trend in Division membership.

- Steve Ressler asked why membership is decreasing if colleges are growing?
- Norm Dennis notes that this conference has become very expensive and it is difficult to justify on a grant unless you are doing education specific research.
- Ken Fridley notes that departments are often covering conference costs for new faculty and they are sending to technical conferences, which are less expensive. The return costs are too low.
- Steve Burian indicated a lack of interest at his university and that they couldn't give away attendance at this year's event that was local to his university and the Dean offering to cover registration. The perceived value wasn't there.
- Norb Delatte stated that the Professors of Practice typically don't have targeted development.
- Sean St.Clair informed the meeting of the planned survey by ASCE's Committee on Education to Department Heads on perceived ASEE value and that ASEE Board has membership Task Force. St.Clair recommended Matt Lovell to follow up with PIC to learn Task Force findings.
- Sean St.Clair also challenged the meeting that since we find value in ASEE and to ask ourselves how do we bring in others? Steve Burian nominated himself to work with Matt Lovell on this.

7. Other business/discussion Brock E. Barry

Item #1 - Division Operating Manual

Brock Barry has taken a first cut at creating a CE Division Operating Manual and Tom Lenox provided a review. The intent of this document is to provide guidance to the Division leadership regarding their responsibilities. This is not an ASEE Board approved document. It is a living document and all Division leadership should be encouraged to update the document as they feel is appropriate. Everyone should view this as an opportunity to pass along insight and suggestions to the next person in line to take over a leadership position. The single copy of this document will be maintained in a folder on Dropbox. The document's utility will grow as more and more individuals update it.

Barry indicated that all officers are to put their files in the division Dropbox.

#2 Civil Engineering Education Summit May or June 2019 in combination with the Department Heads Council Conference.

#3 Andrea Welker indicated all future Program Chairs should remind authors to update their original abstract on Monolith because that is the abstract that is actually published with the paper and will include the original edits that include author and university anonymity.

#4 CJ Riley gave a Bylaw report and stated provided award support varied per award and proposed changing the language to be consistent. As an example, the Seeley award language also does not explain what it is. He proposes changing the name to the Seeley Best Young Faculty paper award.

The Division should also insert sentences for each award describing the person the award is named after. Sean St. Clair proposed combining all award changes for next year as it is difficult to push award changes through ASEE. Brock Barry volunteered to help CJ Riley with this. Norm Dennis reminded the meeting that the name change for the Stephen Ressler Best Paper Award is not ASEE Board approved because Ressler is still alive. The Division has added the name change to our bylaws, which were Board approved, but the award name change was never Board approved.

#5 Sean St.Clair asked first-time attendees to raise their hand and then asked continuing members to seek them out.

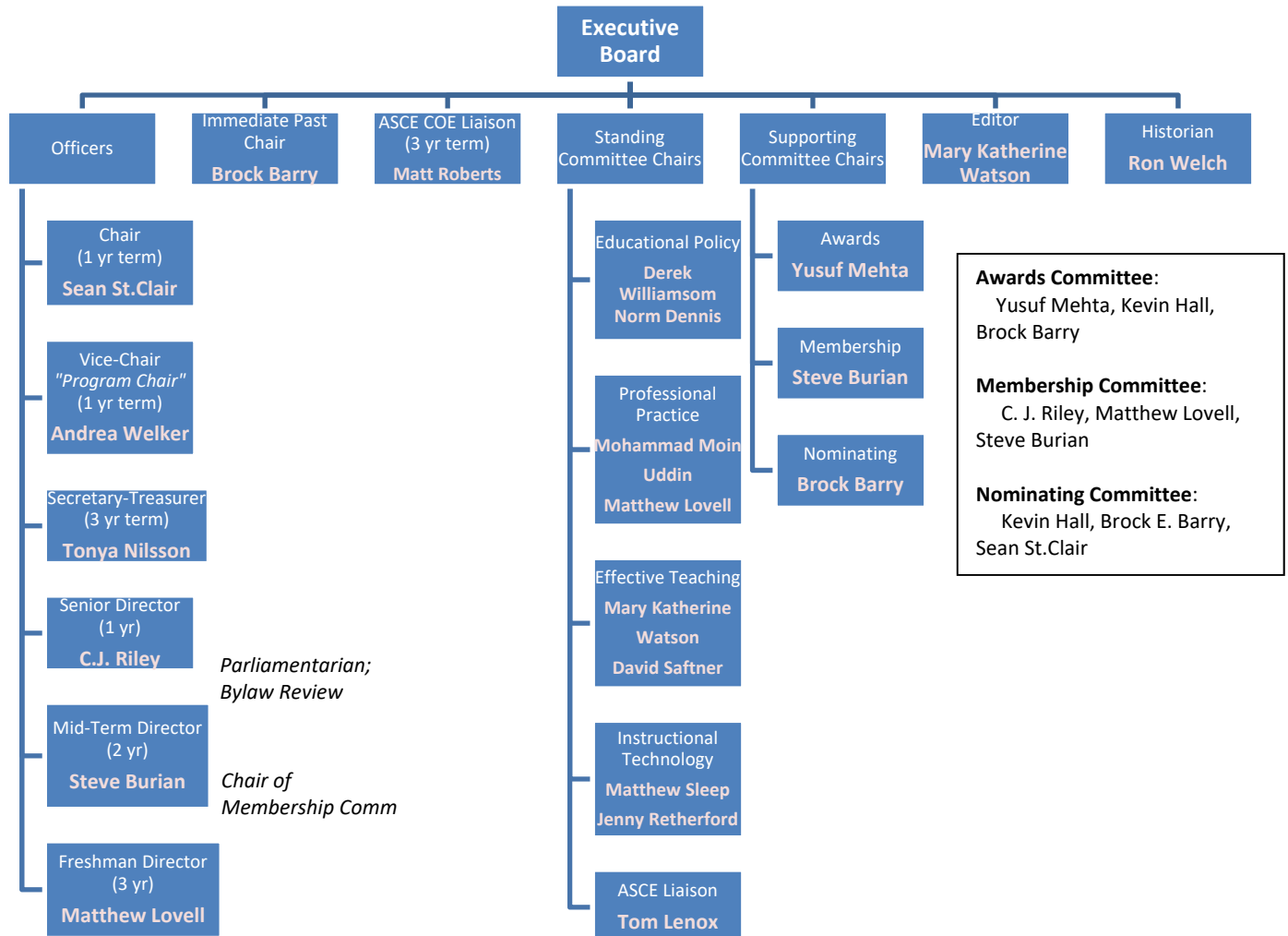

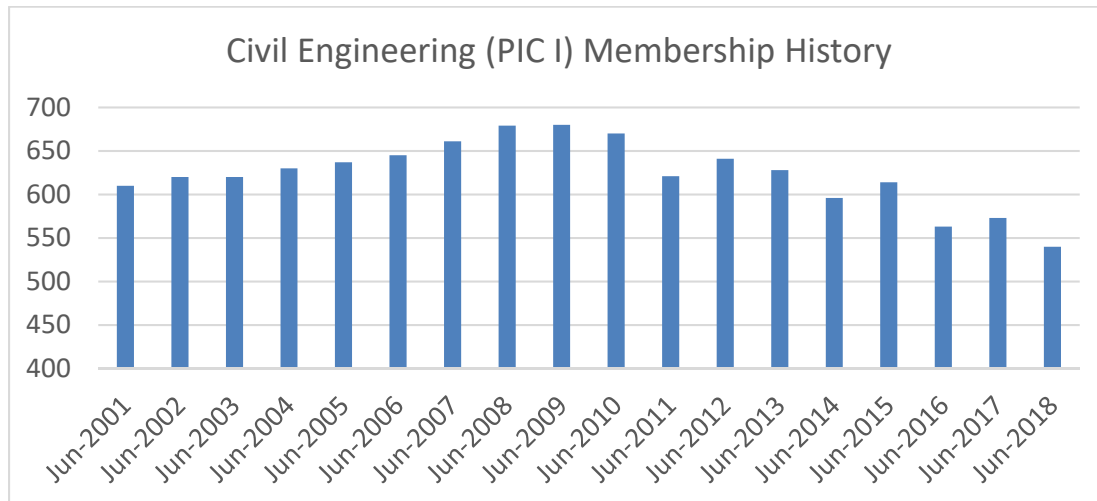

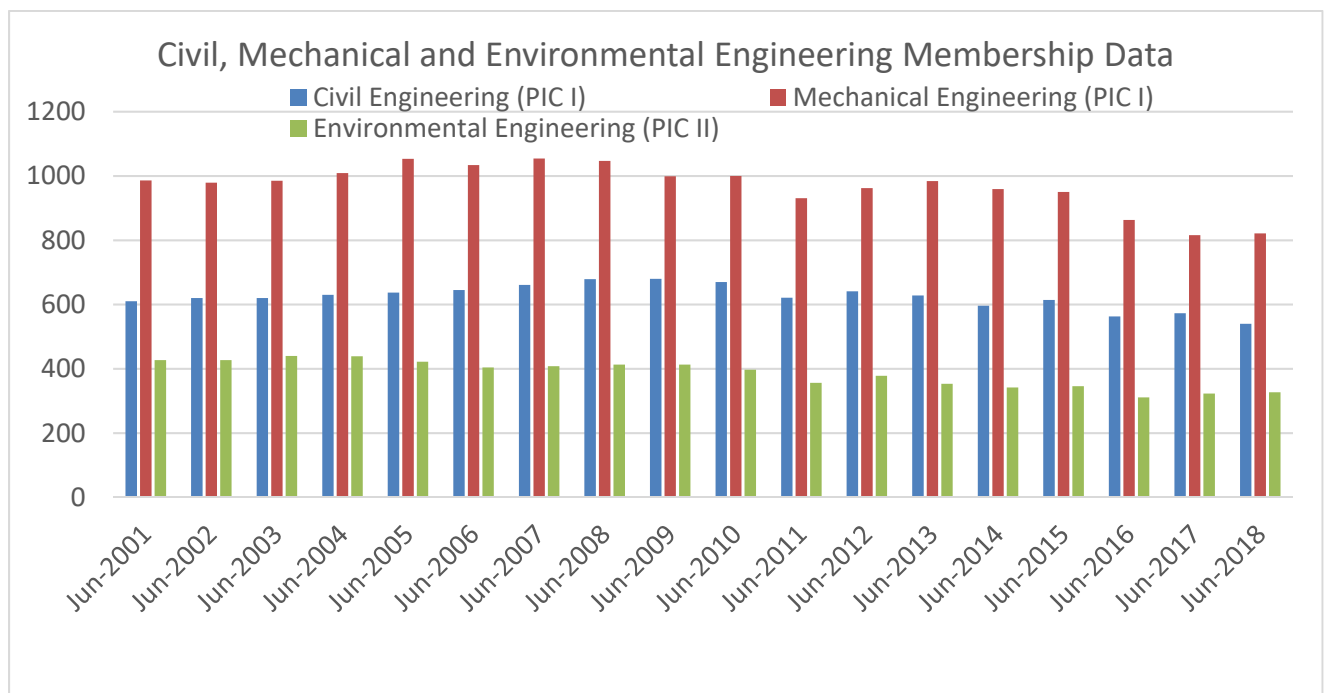

Membership Report**

Membership is at an all-time low since 2001 with 540 members. This is 11.5 percent lower than 2001 membership of 610 members and 20.5 percent lower than the peak membership of 680 members in 2009.



Other divisions are also showing reduced membership from the peak numbers in 2008-2009. Mechanical Engineering and Environmental Engineering have seen reductions but membership totals between 2016 and 2018 have seen slightly less loss than the Civil Engineering Division.

Inventory of Division Newsletters


